

## ELIGIBILITY

### The KTYD “What’s that from?” Contest

NO CONSIDERATION OR PURCHASE IS REQUIRED TO ENTER OR WIN. CONSIDERATION OR PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.

This contest is open to California residents age 18 or older. 3. The morning personalities will keep taking calls until the correct answer is given. The first listener with the correct answer will be a cash card valued at \$100.
4. There is a guarantee of \$500 to be given away the first week and second week. A grand total of \$1000 is guaranteed to be given away during the contest period. The contest period will start on Friday, October 1, 2021 with clues announced at designated hours. Contest giveaways will start on Monday, October 4, 2021 and will continue on each weekday through Friday, October 15, 2021, a total of ten (10) contest days.

Recorded promos will begin Friday, October 1, 2021 and will air numerous times randomly between 6am and Midnight throughout the duration of the contest period. The promos will highlight how the contest works and will direct listeners to the KTYD website ([www.ktyd.com](http://www.ktyd.com)) for complete contest rules which will be prominently identified on the website.
